The Assessor shall, at the same time, forward a copy of the verified list of corrections to the County Director of Real Property Tax Services. Any corrections of erroneous entries shall be of no force or effect unless such corrections are included on the verified list of corrections and the duplicate copy of such list filed with the County Director of Real Property Tax Services.
