

NORTHSIDE LINE

- ▶ STAGE 1: PARKER AVE TO HUDSON HERITAGE
- ▶ STAGE 2: KITTREDGE PLACE TO FULTON ST
- ▶ STAGE 3: NORTH HAMILTON ST TO PARKER AVE
- ▶ 24/7/365 OPERATION
- ▶ LIGHTING AND CAMERAS






NORTHSIDE LINE STAGE 1

KEY FEATURES

- ▶ PARKER TO WEST CEDAR “SPLIT TRAIL”; 8’ PEDS, 10’ BIKE, 4’ MEDIAN
- ▶ WEST CEDAR TO SHOP RITE, 16’ WIDE W/O MEDIAN
- ▶ WALKWAY OVER THE HUDSON ACCESS

SCHEDULE

- ▶ PARKER TO CEDAR ANTICIPATED COMPLETE MAY 1, 2023
- ▶ FULL TRAIL ANTICIPATED COMPLETE FALL 2023
- ▶ COST AS BID, \$12.62M



NORTHSIDE LINE STAGE 2

KEY FEATURES

- ▶ “SPLIT TRAIL” FULL LENGTH
- ▶ MARIST CONNECTIVITY
- ▶ SIDEWALK IMPROVEMENTS TO FULTON AND WEST CEDAR

SCHEDULE

- ▶ FINAL DESIGN AND PERMITTING UNDERWAY
- ▶ BIDDING FALL 2023
- ▶ CONSTRUCTION COMPLETE LATE 2024
- ▶ ANTICIPATED COST \$11M






ADA COMPLIANCE

- ▶ PART OF COUNTY ADA IMPROVEMENT PROGRAM






INNIS AVENUE

KEY FEATURES

- ▶ REPLACE AND WIDEN WEST SIDE SIDEWALK
- ▶ ADA COMPLIANT RAMPS AT CROSSINGS
- ▶ TRAFFIC SIGNAL REPLACEMENT AT DELEVAL

SCHEDULE

- ▶ BID OPENING FEB/MARCH
- ▶ CONSTRUCTION SPRING 2023 TO FALL 2023
- ▶ ESTIMATED \$1.4M COSTS



MAPLE AVENUE

KEY FEATURES

- ▶ FISH STREET TO HIGHLAND DRIVE
- ▶ REPLACE AND WIDEN WEST SIDE SIDEWALK
- ▶ ADA COMPLIANT RAMPS AT CROSSINGS

CHALLENGES

- ▶ SIGNIFICANT GRADE ISSUES
- ▶ ROUTE 44 INTERSECTION

SCHEDULE

- ▶ DESIGN CONCEPTS EARLY 2023
- ▶ FINAL DESIGN COMPLETE LATE 2023
- ▶ CONSTRUCT 2024. TARGETING \$1.0M ESTIMATE

BEYOND 2023

NORTHSIDE LINE PHASES 2 & 3

- PHASE 2 BID 2023, CONSTRUCTION 2024
- PHASE 3 BID 2024, CONSTRUCTION 2025
- ALL TRAIL FUNDING BY DUTCHESS COUNTY DIRECTLY

FUNDING REQUEST FOR ADDITIONAL ADA PROJECTS

- CR 72, 73, OR 71 IN PLEASEANT VALLEY (NORTH AVE, SHEROW RD, WEST RD)
- CR 34 IN FISHKILL (BAXTERTOWN ROAD)
- PROJECT SELECTION IN COORDINATION WITH DC PLANNING
